MINUTES

1. Welcome and Introductions

Elizabeth Adams and Yvonne Nelson welcomed everyone and introductions were made.

2. CAPC Reconsideration of the Covid-19 State of Emergency

- a. The CAPC reconsidered the circumstances of the COVID-19 state of emergency;
- b. The CAPC considered whether state of local officials continue to impose or recommend measures to promote social distancing;
- c. It was found that the CAPC reconsidered the circumstances of the state of emergency, and that State or local officials continue to impose or recommend measures to promote social distancing and;
- d. A motion was made by Alison Wales, seconded by John Crowell to direct staff to continue to notice and hold hearings as remote hearings consistent with Government Code § 54953(e)(3). The motion carried by the following votes: YES-19 NO-0 ABSTAIN-0

3. Approve Minutes from February 17, 2022

Jacqui Banta motioned to approve the February 17, 2022 minutes and Flo Furuike seconded the motion. Carrie Martin and Kendra Webster abstained from voting; all others voted in favor and the minutes were approved.

4. Public Comment

There was no public comment.

5. Mindful Moment: A Tribute to Tony Hollenback

Elizabeth Adams guided everyone through a mindful moment. Folks shared their memories about Tony.

6. Protective Factor of the Month

The Protective Factor of the Month was Social Connections. Folks were divided into triads and asked to discuss: How do you experience healing in community? Folks shared the following:

- Recognizing that being together in silence is being together; allowing the full human experience
- There are ways to commemorate in the community (ex. 9/11) and there are also ways to commemorate with friends and family
- Togetherness is important
- CAPC is a healing space; we come as community partners
- A healing space is the willingness to be vulnerable, the willingness to share love, and to hold space for each other

7. April Campaign 2022

- **Messaging Work Group**
- **Social Media / PSA**
- **OCAP resources**

Barbara shared that there will be weekly themes in April based on the buffering services that are part of the ACEs Aware Initiative. They will go as follows:

- Week 1: Balanced Nutrition
- Week 2: Mindfulness
- Week 3: Experiencing Nature
- Week 4: Supportive Relationships

Members reviewed messaging that the Messaging Committee put together and gave feedback (see attached PPT).

A document that can be used for board presentations, staff meetings, pinwheel events, etc. will be created with this information. Folks can modify it as they see fit. Barbara went over the current CAPC 2022 Activities (see attached PPT). Folks shared the following April campaign activities:

- Casa Pacifica - Kimberly stated that the pins, pens and buttons they ordered will be distributed among their staff and worn while they talk with their clients. Their smaller teams might take group photos.
- NCRCCPC - Alison mentioned that after a few weeks of pinwheels, they will be erecting little wooden children, colored in blue and pink, that will represent sexual abuse statistics.
- SYVPHP - John shared that People Helping People will do a pinwheel garden, tentatively for April 4th in front of the Veterans' Hall building. They also ordered lapel pins for school district staff to wear throughout the month.
- SBCEO - Elizabeth shared that she is meeting with Christian to figure out a plan. Last year, they had pinwheels in front of each of their county campuses and they plan to do something like this again. She added that Hope School District liked participating last year so they will probably work with them again. They have their countywide liaisons meeting next Tuesday and there will be breakout groups to talk about what the districts can do districtwide throughout the county about child abuse prevention. Elizabeth will be sharing this messaging with them so that they can put it out to their families.
- Barbara mentioned that CenCal Health will support our child abuse prevention campaign again this year. Last year, the North County Rape Crisis and Child Protection Center was the recipient of their donation and this year it is going to go to Children's Resource and Referral.
- Natalia shared that CRR will be having a day at the park for families and childcare providers, with education and fun. They will provide families with buckets with family activity ideas and will encourage them to share on social media platforms. CRR will put materials in the buckets to help initiate family activities like popcorn for family movie night etc.

- Lydia shared that they launched a webinar series called [Reimagining Prevention](https://www.caltrin.org/upcoming-training-by-topic/reimagining-prevention-webinar-series/) in partnership with OCAP and CalTrin, which is the California Training Institute. They will be updating the link with materials from webinars that have already happened. The next one is coming up on March 30th titled “The Roadmap to Comprehensive Prevention Planning”.

8. Building a Prevention Inventory

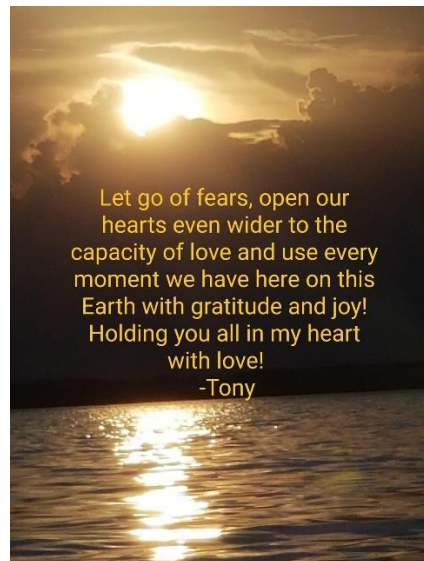
Due to lack of time, this will be discussed at a later meeting.
